


Together, We Create Art

ART KAOHSIUNG Art Fair (hereinafter referred to as ART KAOHSIUNG) has established a strong cultural foundation in southern Taiwan through its extensive experience in organizing art fairs. By uniting resources from industry, government, and academia, it has opened a gateway for Taiwanese contemporary art to engage with the international community.





Fair Schedule

December 31th | Deadline for Application and Deposit Payment

Exhibitors are required to submit the application form and a deposit of USD 200 to complete the registration. The deposit of unsuccessful applicants will be refunded after deducting administrative fees. Exhibitors who withdraw after acceptance will not receive a refund of the deposit.

To ensure participation eligibility and benefits, please settle the payment and submit the Catalog and Media Promotion Form on time. The payment date will be based on the date of bank remittance or check issuance. The organizer reserves the right to cancel the participation eligibility of exhibitors who fail to pay the booth fee by the deadline.
